KIND Founded

Microsoft and Co-Founder and Patron Angelina Jolie launch KIND in October 2008 to ensure that no child appears in immigration court alone. KIND creates a movement to help unaccompanied children in their legal proceedings through a dedicated network of lawyers from law firms and corporations who volunteer to represent these children in their immigration proceedings in the United States.

Our First Year

KIND opens our doors to children in seven cities in the United States: Baltimore, MD; Boston, MA; Houston, TX; Los Angeles, CA; Newark, NJ; New York, NY; and Washington, D.C., also home to our headquarters, with 12 staff members.

Our Pro Bono Model

Children from 40 countries seek our help with their case for U.S. protection.
Through our innovative pro bono model, KIND's staff of 25 provides mentorship and training to our 80 pro bono partner law firms and corporations who represent and provide legal assistance to unaccompanied children.

Helping Children Return to Guatemala

A Focus on Legal Services

KIND doubles our reach, serving children from 66 countries in partnership with more than 150 law firms, bar associations, corporations, and law schools. We continue to provide comprehensive training on representing unaccompanied children and mentor attorneys throughout every stage of their client's case.

Partnerships on the Rise

KIND's network of pro bono attorneys donates over \$60 million in pro bono assistance since our founding. KIND merges with Volunteer Advocates for Immigrant Justice, which becomes our eighth office in Seattle, WA.

Child Migration Emergency

KIND provides vital legal assistance and engages in robust advocacy in response to the more than 68,000 unaccompanied children who arrive at the U.S.-Mexico border in 2014, an unprecedented number of child arrivals and a tenfold increase from 2009. Most children have fled growing violence in Central America and do not have attorneys by their side when they face the U.S. immigration system.

Broadening Our Reach

KIND opens offices in San Francisco, CA and Atlanta, GA-bringing our total to 10 offices nationwide. We launch our social services program and strengthen psychosocial support of our child clients to help them recover from trauma and adjust to life in the United States.

KIND Expands Globally

KIND expands our Child
Migrant Return and
Reintegration Program
to include children from
Honduras, launches KIND
U.K. based on our U.S.
pro bono model and in
collaboration with U.K.
legal services organizations
eager to build pro bono
programming in the U.K.,
and creates the Voices That
Matter Most, a storytelling
project to help children share
their immigration stories.

A New Political Landscape

KIND's total number of law firm, corporate, law school, and bar association partners reaches 515.

We advocate against the new Administration's draconian immigration restrictions and efforts to weaken access to protection for unaccompanied children.

Family Separation Response

KIND deploys teams to the border to provide legal information to detained parents forcibly separated from their children at the U.S.-Mexico border due to the Administration's Zero-Tolerance policy. We begin representing separated children whose parents were deported or remained in detention, and support reunification efforts.

KIND Brings Pro Bono Model to Europe

KIND expands our pro bono work to help unaccompanied and separated children in Europe access free legal assistance in partnership with nongovernmental organizations in Greece, France, Ireland, and Belgium.

Protection Amid the Pandemic

KIND adapts to provide legal and social services to our clients and to mitigate the impact of the pandemic on children and their families.

KIND Expands in Mexico

KIND's new offices in Tijuana, Ciudad Juárez, Mexico City, and Tapachula promote the rights of children migrating from, to or through Mexico, focusing on Mexico's northern and southern border regions. In response to the influx of children at the U.S.-Mexico border, we begin working in emergency intake sites where we provide vital Know Your Rights presentations for children in government custody.

We Go Where the Children Are

As record numbers of unaccompanied children continue to arrive in the United States, KIND expands our reach and opens offices in El Paso, TX; Fresno, CA; Orlando, FL; and Northern Virginia. We also expand our work in Europe in response to the hundreds of thousands of unaccompanied children forced to flee the war in Ukraine, working with partners in Slovakia and Poland.
