- ▶ **3 ramaj** pa apachike q'ij rech tijonem
- ▶ **8 ramaj** man k'o ta chi upam le ramaj rech tijonem
- ▶ **18 ramaj** pa jun uwuq q'ij rech tijonem o
- ▶ **40 ramaj** pa jun uwuq q'ij man k'o ta-pa le ramaj rech
